**The Board of Directors recommends that you vote FOR the director nominees in proposal 1, FOR proposals 2 and 3, and FOR the option of every ONE YEAR on proposal 4:**

1. Election of Director Nominees for a three-year term expiring at the 2020 Annual Meeting: Steven E. Bernstein and Duncan H. Cocroft.
2. Ratification of the appointment of Ernst & Young LLP as SBA's independent registered public accounting firm for the 2017 fiscal year.
3. Approval, on an advisory basis, of the compensation of SBA's named executive officers.
4. Approval, on an advisory basis, of the frequency of future advisory votes on the compensation of SBA's named executive officers.

**Note.** Such other business as may properly come before the Annual Meeting and any postponements or adjournments thereof.
