- (1) The Restricted Stock Units (RSUs), the conversion of which are reported herein, were granted to the reporting person by the issuer as part of the equity incentive grants made by the issuer on February 18, 2005. The RSUs vest in equal portions over a 3 year period and are received by the reporting person upon vesting unless the reporting person has previously chosen a longer deferral period.
