Novo Nordisk A/S – Share repurchase programme

Bagsværd, Denmark, 18 March 2013 – On 31 January 2013 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission’s regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 3.0 billion in the period from 31 January 2013 to 29 April 2013.

Since the announcement as of 11 March 2013, the following transactions have been made under the programme:

With the transactions stated above, Novo Nordisk owns a total of 19,198,829 treasury shares, corresponding to 3.4% of the share capital. The total amount of shares in the company is 560,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares for an amount up to DKK 14.0 billion during a 12 month period beginning 31 January 2013. As of 15 March 2013, Novo Nordisk has repurchased a total of 1,591,310 B shares equal to a transaction value of DKK 1,592,822,955.

Novo Nordisk is a global healthcare company with 90 years of innovation and leadership in diabetes care. The company also has leading positions within haemophilia care, growth hormone therapy and hormone replacement therapy. Headquartered in Denmark, Novo Nordisk employs approximately 35,000 employees in 75 countries, and markets its products in more than 180 countries.
