- (1) The shares vest in three annual installments, beginning two years from date of grant on February 13, 2009. The shares were awarded under the terms of Questar's Long-term Stock Incentive Plan.
- (2) As of February 19, 2007, I have 1,219.9360 equivalent shares of stock in Questar's Employee Investment Plan. The number of equivalent shares will fluctuate as Questar's stock price changes; this fluctuation does not reflect any transactions that should be reported.
- (3) Phantom stock units will be converted to cash beginning at retirement; my retirement date is unknown.
- (4) I also receive phantom stock units as a result of my participation in an excess benefit plan. This total includes 14,813.7462 units in such plan, in addition to units held through my account balance in a deferred compensation plan. I also receive dividends.
- (5) I have been granted an option to purchase 40,000 shares at a price of \$82.15 such shares vest in three equal annual installments beginning February 13, 2009. The expiration date of these options is February 13, 2014.
