The number of Units paid, which could have been 0% to 200% of the base number of Units granted, depended 50% on cumulative net
- (2) income and 50% on cumulative total cash flow, net of debt during the 3-year performance period ending December 31, 2009. This Form 4 reports the conversion of 7,700 Units, 100% of the base number of units granted, payable 50% in common stock, 50% in cash.
Performance Unit Grant of a maximum of 14,129 units (150% of the base number of Units granted) under the 2008 Performance Plan, contingently payable (to the extent earned) 100% in shares of Common Stock, in February, 2013. The grantee may elect to defer (in
- (3) Common Stock equivalents) all or a portion of the grant earned. Amounts deferred will be paid in shares of Common Stock. The number of Units paid, which can be zero to 14,129 Units, depends 50% on the attainment of a net income target and 50% on the attainment of a cash flow target over a 1-year period ending December 31, 2010.
- (4) Non-Qualified Stock Option in respect of shares of common stock granted under the 2008 Performance Plan.
- (5) The option vests and becomes exercisable in 25% increments over four years commencing one year after the date of grant.
- (6) Restricted Stock Units, each equivalent to a share of common stock, granted under the 2008 Performance Plan.
- (7) The Restricted Stock Units vest and convert into shares of common stock in 33% increments each year commencing three years after the date of grant.
