- (2) All of the shares reported as disposed of on this Form 4 were relinquished by the Reporting Person in exchange for the Company's agreement to pay federal and state withholding obligations of the Reporting Person resulting from the vesting of the restricted units.
- (3) Vesting of performance-based restricted units granted to the Reporting Person on March 1, 2007.
- (4) These restricted units vested ratably on each of the first, second and third anniversaries of the date of grant. Restricted units are settled in shares of the Company's common stock upon vesting.

(CF) These restricted units were granted subject to cliff vesting conditions based on the average closing price of the Company's common stock on the last 40 trading days of 2009 ("Stock Price"), with vesting occurring on the third anniversary of the date of grant, as follows:
- (5) 10,000 restricted units to vest if the Stock Price is \$6.75 or less; 20,000 restricted units to vest if the Stock Price is \$8.50; and 30,000 restricted units to vest if the Stock Price is \$10.25 or greater. Based on the Stock Price of less than \$6.75, 10,000 restricted units vested on March 1, 2010.
