## Explanation of Responses:

(1) Shares have been withheld to cover the reporting person's tax liability in connection with the incentive performance unit opportunity granted on January 15, 2008 and awarded on February 8, 2011.

(2) On January 15, 2008, the Personnel and Compensation Committee of the PNC Board of Directors granted an incentive performance unit opportunity to the reporting person. The grant was expressed as a "target" number of share units, and was adjusted for dividend equivalents over the three-year performance period. Subject to the Committee's discretion, the reporting person is eligible to receive shares of PNC common stock (if PNC meets specified performance criteria up to the target level) and/or cash (if the performance criteria exceeds the target level). PNC exceeded the target level performance criteria, which resulted in the vesting of 16,000 shares of PNC common stock.

(3) Dividend reinvestment shares acquired under the PNC Incentive Savings Plan.

(4) One phantom stock unit is the economic equivalent of one share of The PNC Financial Services Group, Inc. ("PNC") Common Stock.

(5) Phantom Stock Units received as dividend equivalents under the PNC Deferred Compensation Plan.

(6) Phantom Stock Units will be settled in cash upon distribution from the reporting person's plan account and generally do not expire.

(7) Phantom Stock Units received as dividend equivalents under the PNC Supplemental Incentive Savings Plan.
