Options for the purchase of 1,531 shares will vest on January 15 of each of 2013 and 2014 and options for the purchase of 1,530 shares will vest on January 15 of each of 2015, 2016 and 2017.
- (3) The options were granted under the Amended and Restated Health Care REIT, Inc. 2005 Long-Term Incentive Plan and had no acquisition price.
- (4) These deferred stock units were granted without cash consideration on January 26, 2012 under the Amended and Restated Health Care REIT, Inc. 2005 Long-Term Incentive Plan. Each deferred stock unit represents a right to receive one share of common stock of Health Care REIT, Inc. at the time of vesting of the unit. These deferred stock units vest in four installments with 1,091 units vesting on January 31, 2012 and 1,090 units vesting on January 31 of each of 2015, 2016 and 2017.
