- (2) Options for the purchase of 24,103 shares of common stock at \$57.33 per share were granted to Mr. Miller on January 26, 2012. Options for the purchase of 4,821 shares will vest on January 15 of each of 2013, 2014 and 2015 and options for the purchase of 4,820 shares will vest on January 15 of each of 2016 and 2017.
- (3) The options were granted under the Amended and Restated Health Care REIT, Inc. 2005 Long-Term Incentive Plan and had no acquisition price.
- (4) These deferred stock units were granted without cash consideration on January 26, 2012 under the Amended and Restated Health Care REIT, Inc. 2005 Long-Term Incentive Plan. Each deferred stock unit represents a right to receive one share of common stock of Health Care REIT, Inc. at the time of vesting of the unit. These deferred stock units vest in four installments with 4,361 units vesting on January 31, 2012, 4,361 units vesting on January 31 of each of 2015 and 2016 and 4,360 units vesting on January 31, 2017.
