- (1) The restricted stock unit award includes a total of 5,957 shares. 1,787 shares of the restricted stock unit award will vest on January 31, 2014; an additional 1,787 shares will vest on January 30, 2015; and the remaining 2,383 shares will vest on January 29, 2016. The resulting shares of common stock received upon settlement will be subject to the restrictions on transfer included in the TARP Interim Final Rule's definition of "long-term restricted stock" until M&T repays the remainder of its TARP obligation.
 - (2) The restricted stock units were granted under an incentive compensation plan maintained by M&T Bank Corporation, and therefore the reporting person paid no price for the restricted stock units.
