The Restricted Stock Units ("RSUs") granted on 02/10/2012 vest 25% on each of the first four anniversaries of the date of grant. 856 (1) RSUs, that included accrued dividend equivalents, vested on 02/10/2013 and were paid out in the form of Republic Services, Inc.'s common stock.

Represents shares of common stock to satisfy the tax liability of the Reporting Person upon the vesting of 856 shares under the Restricted (2) Stock Unit award. The fair market value of the exchanged shares was \$31.12 (the closing price of Republic Services, Inc.'s common stock on 02/08/2013 (02/10/2013 was on a Sunday)).

Restricted Stock Units ("RSUs") awarded pursuant to Republic Services, Inc.'s 2007 Stock Incentive Plan, as amended. The award will (3) vest 25% on each of the first four anniversaries of the date of grant (which date of grant is 02/08/2013) and each RSU ultimately will be paid out in the form of one share of Republic Services, Inc.'s common stock. The number of RSUs was calculated based on the closing price of Republic Services, Inc.'s common stock on 02/08/2013 (\$31.12).

(4) Non-Qualified Stock Options awarded pursuant to Republic Services, Inc.'s 2007 Stock Incentive Plan, as amended. The award will vest 25% on each of the first four anniversaries of the date of grant (which date of grant is 02/08/2013).
