  - (2) On October 3, 2013, the remainder interest of the GRAT consisting of 297,130 shares was transferred to the Nayden 2009 Family Trust dtd. 6/29/2009 (the "Trust"). The reporting person's children are the beneficiaries of the Trust.
  - (3) This option was issued to the reporting person pursuant to the Accretive Health director compensation plan in lieu of retainer fees of \$15,000.
