(This footnote is continued onto footnote 3).

(3) The common stock number referred in Table I is an aggregate number and represents 2,628 shares of common stock of ICE, 908 deferred compensation obligations of ICE and 1,291 restricted stock units of ICE. The restricted stock units vest on the one-year anniversary of the grant date, which is February 28, 2014.
