- (1) The restricted stock units granted on May 7, 2014 will vest 100% on the first anniversary of the grant date. This is an annual non-employee director grant as outlined in the 2014 proxy.
- Mr. Grady has been granted a total of 51,000 RSUs in seven grants: (A) 15,000 RSUs granted on May 7, 2008;(B) 6,000 RSUs granted on May 6, 2009; (C) 6,000 RSUs granted on May 4, 2010. These RSUs vest in 4 equal installments beginning 1 year from grant date. (D) 8,000 RSUs granted May 4, 2011; (E) 8,000 RSUs granted May 2, 2012; (F) 8,000 RSUs granted May 1, 2013; (G) 8,000 RSUs granted May 7, 2014. These RSUs (D-G) will vest 100% on the first anniversary of the grant date. As of this filing date,10,800 RSU shares are in street name.
