- (1) On March 2, 2017, the reporting person exchanged assets of equal value for 355,307 Class A Common Shares, which were valued based on the average of the high and low market price of the Class A Common Shares on such date, with a grantor-retained annuity trust of which the reporting person is trustee. As a result, these Class A Common Shares are again directly owned by the reporting person.
  - (2) These shares were previously reported as directly beneficially owned, but were contributed on September 4, 2015, to a grantor retained annuity trust of which the reporting person is trustee.
  - (3) On March 2, 2017, the reporting person exchanged assets of equal value for 334,624 Common Voting Shares, which were valued based on the average of the high and low market price of the Class A Common Shares on such date, with a grantor-retained annuity trust of which the reporting person is trustee. As a result, these Common Voting Shares are again directly owned by the reporting person.
