(1) On October 1, 2018, the common stock of Neonode Inc. underwent a 1-for-10 reverse split, resulting in the reporting person's ownership of 750,000 shares of common stock immediately prior to the reverse split being converted into 75,000 shares of common stock immediately after the reverse split.
