(1) Disposed of pursuant to that certain Agreement and Plan of Merger dated as of January 5, 2011 (the "Merger Agreement"), by and among Atheros Communications, Inc., a Delaware corporation (the "Issuer"), Qualcomm Incorporated, a Delaware corporation ("Qualcomm"), and T Merger Sub, Inc., a Delaware corporation and a wholly owned subsidiary of Qualcomm ("Merger Sub"), pursuant to which Merger Sub merged with and into the Issuer with the Issuer surviving the merger as a wholly owned subsidiary of Qualcomm (the "Merger"), in

exchange for \$45.00 per share on the effective date of the Merger.

- (2) 25% of the options became exercisable on 4/4/2009, and the remaining options become exercisable in 36 equal monthly installments commencing on 5/4/2009. All of the options became exercisable upon the effective date of the Merger.  
  
This option was cancelled and converted into the right to receive a cash payment equal to the number of shares of the Issuer's common stock underlying this option multiplied by the amount, if any, that \$45.00 exceeded the exercise price of this option, less any applicable withholding taxes, pursuant to the Merger Agreement.
- (4) The options become exercisable in 48 equal monthly installments commencing on 6/22/2009. All of the options became exercisable upon the effective date of the Merger.
- (5) The options become exercisable in 48 equal monthly installments commencing on 6/24/2010. All of the options became exercisable upon the effective date of the Merger.
