Clarification on the Port of Itaguaí

Rio de Janeiro, March 17th, 2011 Petróleo Brasileiro S.A. On July 7th, 2009, the Company informed the market about the signing of a Memorandum of Understanding (MOU) with Gerdau S.A and Companhia Siderúrgica Nacional (CSN) in order to study the possibility of jointly executing a port facilities development project in Sepetiba Bay.
