Acquisition of INNOVA

Rio de Janeiro, April 1st, 2011 – Petróleo Brasileiro S.A - Petrobras, announces the acquisition of 100% of the capital of Innova S.A., in the amount of US\$ 332 million, from Petrobras Energía Internacional S.A. – PEISA, a wholly owned subsidiary of Petrobras Argentina SA.

The acquisition allows Petrobras to invest at Innova aiming to align its assets to Petrobras' business plan. On the other hand, Petrobras Argentina will concentrate its business in Argentina.

Innova is located in the Petrochemical Complex of Triunfo-RS (Brasil), produces styrene, polystyrene, and ethylbenzene, raw materials for synthetic rubber, acrylic and polyester resins used for disposables, paper, tires, paints and packages, among others.
