To the Company's knowledge, Mr. Gorman's decision is not the result of any disagreement with the Company on any matter relating to the Company's operations, policies or practices. Mr. Gorman has served as a director of the Company since its spin-off from Ceridian Corporation in March 2001. Mr. Gorman indicated that he was informing the Company of his decision at this time so that the Company would have adequate time to identify and nominate a replacement director to fill the vacancy that would otherwise be created as a result of his retirement.
