**Item 1.01 Entry into a Material Definitive Agreement.**

The Research Institute of McGill University Health Centre

Samaritan Pharmaceuticals executed a research collaboration (the "Research Collaboration") with The Research Institute of McGill University Health Centre and Samaritan Therapeutics. The budget is for \$1,000,000 paid over four (4) quarterly payments of \$250,000, is unallocated, and covers the general research and development effort.

Under the Research Collaboration, Samaritan Pharmaceuticals receives worldwide exclusive rights, excluding Canada, to any novel therapeutic agents or diagnostic technologies that may result from the Research Collaboration. Samaritan Therapeutics receives exclusive rights to the Canadian market to any novel therapeutic agents or diagnostic technologies that may result from the Research Collaboration.

There is no obligation to pay The Research Institute of McGill University Health Centre any milestone payments. The Research Institute of McGill University Health Centre is entitled to receive royalties based on revenue from product sales and sublicenses, if any. Samaritan Pharmaceuticals and Samaritan Therapeutics have assumed responsibility, at their own expense, for the process of seeking any regulatory approvals for and conducting clinical trials with respect to any licensed product or application of the licensed technology. Samaritan Pharmaceuticals and Samaritan Therapeutics collectively control and have the financial responsibility for the prosecution and maintenance in respect to any patent rights related to the licensed technology.

**Item 1.02 Termination of a Material Definitive Agreement.**

In the second quarter of 2007, Samaritan Pharmaceuticals terminated the Georgetown University research collaboration; however, Samaritan Pharmaceuticals' existing worldwide exclusive rights to licensed technologies with Georgetown will remain in force under the terms of their respective license agreements.
