On May 17, 2013 GFN announced the completion of the public offering of 350,000 shares of its 9.00% Series C Cumulative Redeemable Perpetual Preferred Stock (the "Series C Preferred Stock") the sale of which generated gross proceeds of \$35 million, before deducting the underwriting discount and other estimated offering costs. The shares are listed on the NASDAQ Global Select Market under the symbol "GFNCP" and began trading on May 17, 2013.
