Item 8.01 Other Events

On October 17, 2014 GFN announced that the GFN board of directors has declared a cash dividend of \$2.30 per share on the 9.00% Series C Cumulative Redeemable Perpetual Preferred Stock of GFN (the "Series C Preferred Stock") that is payable with respect to the period commencing on July 31, 2014 and ending on October 30, 2014. This dividend is payable on October 31, 2014 to Series C Preferred Stockholders of record as of October 30, 2014.

On July 17, 2014 the GFN directors approved an interest payment of \$0.5078125 per 8.125% Senior Note due 2021 (the "Senior Note") that is payable with respect to the period commencing on August 1, 2014 and ending on October 31, 2014. This interest payment is payable on October 31, 2014 to Senior Notes holders of record as of October 15, 2014.
