(1) On March 31, 2013, Mr. Kotick transferred 34,350 restricted share units to the 45121I Trust, a trust for the benefit of Mr. Kotick's minor children. Mr. Kotick does not exercise voting or investment power over the assets held in the 45121I Trust and he disclaims beneficial ownership with respect thereto.

(2) Reflects the closing price of the Company's common stock on the last trading day most immediately preceding the date of transfer. The actual price paid by the 45121I Trust is being determined pursuant to a formula reflecting an independent valuation of the underlying securities.

(3) On March 31, 2013, Mr. Kotick transferred 808,766 performance shares to the 45121I Trust.

(4) Following the transactions reported on this Form 4, Mr. Kotick directly held (a) 1,339,650 restricted stock units, each representing the right to receive a share of the Company's common stock, (b) 3,313,246 performance shares, each representing the right to receive a share of the Company's common stock, and (c) 843,829 shares of the Company's common stock.
