On June 29, 2015, 9,940 restricted stock units held by Mr. Wereb vested. Pursuant to the terms of his restricted stock unit award agreement, the Company withheld 3,736 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.

Following the transactions reported on this Form 4, Mr. Wereb held (a) 13,261 shares of the Company's common stock, (b) 9,701 restricted stock units with vesting tied to performance, each representing the right to receive one share of the Company's common stock and (c) 46,820 restricted stock units, each representing the right to receive one share of the Company's common stock.
