*TSF Acquisition Agreement.*

On May 25, 2007, Legacy Reserves Operating LP, a wholly owned subsidiary of Legacy Reserves LP (“Legacy”), closed its previously announced acquisition (the “TSF Acquisition”) of certain oil and natural gas producing properties located in Midland, Upton and Reagan Counties in West Texas from Terry S. Fields for an aggregate purchase price of approximately \$14.6 million, subject to customary purchase price adjustments, paid in cash.
