**SCHEDULE 13G/A**

This Amendment No. 1 to Schedule 13G (the "Schedule 13G") is being filed on behalf of Sapling, LLC, a Delaware limited liability company ("Sapling"), Fir Tree Capital Opportunity Master Fund, L.P., a Cayman Islands exempted limited partnership ("Fir Tree Capital Opportunity") and Fir Tree, Inc., a New York corporation ("Fir Tree"), relating to common stock, par value \$0.0001 (the "Common Stock") of Stoneleigh Partners Acquisition Corp., a Delaware corporation (the "Issuer"), purchased by Sapling and Fir Tree Capital Opportunity. Fir Tree Value Master Fund, LP, a Cayman Islands exempted limited partnership ("Fir Tree Value"), is the sole member of Sapling, and Fir Tree is the investment manager of both Sapling and Fir Tree Capital Opportunity.

- (a) Sapling and Fir Tree Capital Opportunity are the beneficial owners of 1,457,950 shares of Common Stock and 322,400 shares of Common Stock, respectively. Fir Tree may be deemed to beneficially own the shares of Common Stock held by Sapling and Fir Tree Capital Opportunity as a result of being the investment manager of Sapling and Fir Tree Capital Opportunity.
- (b) Sapling and Fir Tree Capital Opportunity are the beneficial owners of 4.3% and 0.9%, respectively, of the outstanding shares of Common Stock. Collectively, the Reporting Persons beneficially own 1,780,350 shares of Common Stock which represent 5.2% of the shares of Common Stock outstanding. These percentages are determined by dividing the number of shares of Common Stock beneficially held by 34,097,500, the number of shares of Common Stock issued and outstanding as of according to the Issuer's Form 10-Q filed with the Securities and Exchange Commission on December 14, 2007.
- (c) Sapling may direct the vote and disposition of 1,457,950 shares of Common Stock. Fir Tree Capital Opportunity may direct the vote and disposition of 322,400 shares of Common Stock. Fir Tree has been granted investment discretion over the Common Stock held by Sapling and Capital Opportunity.
