**Item 5.07. Submission of Matters to a Vote of Security Holders.**

The 2016 Annual Meeting of Stockholders of Oil States International, Inc. (the “Company”) was held on May 10, 2016. At the Annual Meeting, the stockholders of the Company (i) elected two Class III nominees to the Board of Directors, (ii) ratified the appointment of Ernst & Young LLP as the Company’s independent registered public accounting firm for the year ended December 31, 2016, and (iii) voted in favor of the compensation of the named executive officers.
