On September 29, 2016, the Board of Directors (the “Board”) of Marathon Petroleum Corporation (the “Company”) increased the size of the Board to eleven members and elected Mr. Abdulaziz F. Alkhayyal as a director of the Company, with such increase in the size of the Board and election effective as of October 26, 2016. Mr. Alkhayyal was appointed to serve on the Board’s Audit Committee and Corporate Governance and Nominating Committee, also effective October 26, 2016.

As a non-employee director, Mr. Alkhayyal will receive compensation in the same manner as the Company’s other non-employee directors. The Company previously disclosed the terms of non-employee director compensation in its definitive proxy statement on Schedule 14A, filed with the Securities and Exchange Commission on March 15, 2016.
