On January 1, 2019 (the "Effective Date"), pursuant to the Agreement and Plan of Reorganization dated as of May 22, 2018, by and between Independent Bank Group, Inc. ("Independent") and Guaranty Bancorp ("Guaranty"), Guaranty merged with and into Independent (the "Merger"). In connection with the Merger, each outstanding share of Guaranty common stock, subject to certain limited exceptions,

(1) was converted into the right to receive 0.45 of a share of Independent common stock, with cash payable in lieu of a fractional share. In connection with the Merger, the reporting person received Independent common stock reported in Table I, in exchange for all of the shares of Guaranty common stock, an aggregate of 150,184 shares, with cash received in lieu of a fractional share of Independent common stock, subject to any required tax withholding under applicable law.
