(1) VMTP Shares were disposed of as a result of a redemption by the Issuer for a redemption price of \$100,000.00 per share (which includes a liquidation preference of \$100,000.00 per share and accrued dividends of \$0.00 per share). PFC is a wholly owned subsidiary of Bank of America Corporation.
