Waterstone Financial, Inc. (the "Company") held its 2015 Annual Meeting of Shareholders on May 20, 2015. The shareholders (i) elected two members of the Company's Board of Directors to serve until 2017; (ii) approved, in an advisory vote, the compensation of the Company's named executive officers; and (iii) ratified the selection of McGladry LLP as Waterstone Financial, Inc.'s independent registered public accounting firm. There were 34,691,087 outstanding shares eligible to vote as of March 23, 2015, the record date for the 2015 Annual Meeting. The results of the matters submitted to a vote at the Annual Meeting of Shareholders were as follows:
