AIP share footnote: The reporting person earned 22,065 shares in respect of performance-based restricted stock unit units (PBRsUs)

(1) based on the company's achievement of certain performance targets for the 2017 performance period, which were vested as shares of common stock on 2/15/18.

(2) Tax withholding footnote: Represents shares withheld to satisfy tax withholding obligations in connection with the vesting of 22,065 shares of common stock underlying PBRsUs on 2/15/18 (see footnote 1).
