(1) Pursuant to restricted stock agreements between the Issuer and the Reporting Person, dated May 21, 2010, June 10, 2011, and March 12, 2012, the forfeiture restrictions lapsed upon Reporting Person's termination from the Issuer on July 31, 2012.
