- stock on the date of the award for ten consecutive trading days, respectively; and 25% of the shares vest in increments of one-third upon the adjusted earnings per share of the Company reaching \$2.69, \$2.91 and \$3.14; and in any event no earlier than one year from the date of the grant, subject to continuing employment at that time. Shares that do not achieve the stock price thresholds on or before November 13, 2018 will be forfeited. Shares that do not achieve the adjusted earnings per share thresholds on or before November 13, 2016 will be forfeited.
