- (1) The option vests if the Company's stock price achieves certain targets within specified timeframes as follows: one-fourth shall vest if Fair Market Value of the Company's stock achieves \$77.03, but not earlier than 6/15/05; one-fourth shall vest if Fair Market Value of the Company's stock achieves \$82.54, but not earlier than 6/15/06; one-fourth shall vest if the Fair Market Value of the Company's stock achieves \$89.41 but not earlier than 6/15/07; and one-fourth shall vest if the Fair Market Value of the Company's stock achieves \$96.29 but not earlier than 6/16/08. All options not otherwise vesting pursuant to the above timetable shall become exercisable on December 13, 2009.
