- (1) Pursuant to the Agreement and Plan of Merger among Unocal Corporation, Chevron Corporation and Blue Merger Sub Inc. (the "Merger Agreement"), each share of Unocal Corporation Common Stock issued and outstanding immediately prior to the effectiveness of the merger on August 10, 2005 (the "Merger"), together with the Preferred Stock Purchase Rights attached thereto, was converted into the right to receive the merger consideration specified in the Merger Agreement.
- (2) Stock Units credited for voluntary deferral of director fees under the 2004 Directors' Deferred Compensation and Restricted Stock Unit Award Plan (the "Directors' Plan").
- (3) In connection with the Merger, each of the 8,181.0441 Director Units owned by the reporting person under the Directors' Plan was converted into Chevron Shares or Chevron Director Units, depending on the reporting person's distribution elections, at the exchange ratio of 1.068831 shares or units for each Unocal Stock Unit. The closing price of Chevron Common Stock on August 10, 2005 was \$62.48.
