NORTH LIBERTY, IOWA - September 7, 2007 - Heartland Express, Inc. (Nasdaq: HTLD) The Board of Directors of Heartland Express, Inc. announced today the declaration of a regular quarterly cash dividend. The \$0.02 per share dividend will be paid on October 2, 2007 to shareholders of record at the close of business on September 20, 2007. A total of approximately \$1.9 million will be paid on the Company's 96.9 million outstanding shares of common stock.

Heartland Express, Inc. implemented a quarterly cash dividend program in the third quarter of 2003. This is the Company's seventeenth consecutive quarterly cash dividend.
