BHP Billiton Limited announces that on 31 May 2007 it purchased 500,000 ordinary shares of BHP Billiton Plc at an average price of 1227.66 pence per ordinary share.

Following the above purchase, BHP Billiton Plc holds 24,910,000 of its ordinary shares as treasury shares and BHP Billiton Limited holds 28,111,714 of the ordinary shares in BHP Billiton Plc, for a total of 53,021,714 shares.
