TEVA RECEIVES FIRST FDA APPROVAL FOR GENERIC PRAVACHOL®

APPELLATE COURT DENIES APOTEX REQUEST FOR INJUNCTIVE RELIEF

Jerusalem, Israel, April 25, 2006 - Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA) announced today that the U.S. Food and Drug Administration has granted final approval for the Company's Abbreviated New Drug Application (ANDA) to market its generic version of Bristol-Myers Squibb's Pravachol® (Pravastatin Sodium) Tablets, 10 mg, 20 mg and 40 mg. Shipment of these products will begin immediately. As the first company to file an ANDA containing a paragraph IV certification for these strengths, Teva has been awarded 180 days of marketing exclusivity.

Teva's Pravastatin Sodium Tablets are indicated for the treatment of certain hyperlipidemias and the primary prevention of coronary events.

Annual brand product sales in the U.S. of the 10 mg, 20 mg and 40 mg strengths were approximately \$1.5 billion for the twelve months ended December 2005.

Today's approval follows an order by the U.S. Court of Appeals for the DC Circuit dissolving an administrative injunction issued April 20, 2006 and denying Apotex's motion for injunctive relief pending appeal.

Teva Pharmaceutical Industries Ltd., headquartered in Israel, is among the top 20 pharmaceutical companies in the world and is the leading generic pharmaceutical company. The company develops, manufactures and markets generic and innovative human pharmaceuticals and active pharmaceutical ingredients, as well as animal health pharmaceutical products. Close to 90% of Teva's sales are in North America and Europe.
