In November 2007, we issued an aggregate of 7,761,710 shares of common stock valued at \$15,523 to Wayne Baker for engineering services previously performed.

In November 2007, we issued an aggregate of 21,000,000 common shares to four accredited investors upon the conversion of \$14,700 in callable secured convertible notes.

In November 2007, we issued an aggregate of 21,000,000 common shares to four accredited investors upon the conversion of \$14,700 in callable secured convertible notes.

In November 2007, we issued an aggregate of 1,600,000 common shares to one accredited investor upon the conversion of \$200,000 in convertible notes.

In November 2007, we issued an aggregate of 9,600,000 common shares to four accredited investors upon the conversion of \$6,720 in callable secured convertible notes.

In November 2007, we issued an aggregate of 11,400,000 common shares to four accredited investors upon the conversion of \$7,980 in callable secured convertible notes.

The offerings and sales were made to a limited number of persons, all of whom were accredited investors, business associates of Itronics Inc. or executive officers of Itronics Inc., and transfer was restricted by Itronics Inc. in accordance with the requirements of the Securities Act. In addition to representations by the above-referenced persons, we have made independent determinations that all of the above-referenced persons were accredited or sophisticated investors, and that they were capable of analyzing the merits and risks of their investment, and that they understood the speculative nature of their investment. Furthermore, all of the above-referenced persons were provided with access to our Securities and Exchange Commission filings.
