Item 5.03 Amendments to Articles of Incorporation.

Effective April 17, 2008, Chesapeake Energy Corporation filed a Certificate of Elimination with the Oklahoma Secretary of State retiring 1,020,000 shares of its 5.00% Cumulative Convertible Preferred Stock (Series 2005B), par value \$0.01 per share. Such shares of 5.00% Preferred Stock were acquired by the Company as the result of a privately negotiated exchange of its common stock for the 1,020,000 shares of 5.00% Preferred Stock.
