(the <u>"Stamford Harbor"</u>), a Delaware limited partnership, on January 1, 2018 (the <u>"Merger"</u>), at which time Stamford Harbor, as the surviving entity, was renamed Point72 Asset Management, L.P. (<u>"Point72 Asset Management"</u>). In connection with the Merger, the investment management agreements between the Former Investment Manager and certain funds it managed were assigned pursuant to the Merger to Point72 Asset Management. As a result, Point72 Asset Management may be deemed to beneficially own the securities of the Issuer underlying such interests, as described in this Amendment.
