The Performance Stock awarded on August 24, 2015 will vest in 33 1/3% installments over five years beginning on the third annual

(1) anniversary of the date that the performance goal is met. The performance goal was met on December 31, 2016 and will therefore begin vesting in 33 1/3% installments on December 31, 2019.

(2) Restricted Stock granted on August 24, 2015 will vest in 33 1/3% installments over five years beginning on the third anniversary of the award date.

(3) The option is exercisable in five equal annual installments. The first installment becomes exercisable on April 20, 2019.

(4) The option is exercisable in five equal annual installments. The first installment became exercisable on April 21, 2017.

(5) The option is exercisable in five equal annual installments. The first installment became exercisable on January 20, 2013.

Once the performance goal has been met, the Performance Stock Option awarded on August 24, 2015 is exercisable in seven equal annual

(6) installments beginning on the first annual anniversary of the award date. The performance goal was met on December 31, 2016.

Therefore, the first installment became exercisable on August 24, 2016.
