On May 24, 2005, the Registrant issued a news release to announce that its Board of Directors had declared a cash dividend of 17 cents per share payable on July 25, 2005 to shareholders of record as of June 30, 2005. On a split-adjusted basis, the current dividend rate is an increase of 6.3% over the dividend rate paid in the same period of 2004.
