Announces Underwriters' Exercise of Over-allotment Option.

Hamilton, Bermuda, October 11, 2006 -- Nordic American Tanker Shipping Ltd. (NYSE: NAT) today announced that the underwriters of its follow-on offering of 5,000,000 common shares, priced at \$32.00 on October 5, 2006, exercised an over-allotment option granted to the underwriters by the Company. The Company will sell an additional 750,000 common shares as a result of the over-allotment exercise.

Bear, Stearns & Co. Inc. and Morgan Stanley are acting as joint bookrunning managers and DnB NOR Markets, Inc., Dahlman Rose & Company, LLC and Scotia Capital (USA) Inc. are acting as co-managers. The Company expects to close the sale of the common shares in the follow-on offering and pursuant to the exercise of the over-allotment option on October 11, 2006, subject to customary closing conditions.

The offering is being made only by means of a prospectus and related prospectus supplement. A prospectus supplement related to the offering has been filed with the Securities and Exchange Commission. About the Company

The Company is an international tanker company that owns nine modern double-hull Suezmax tankers. The Company expects to take delivery of the three additional Suezmax tankers no later than November 2006.
