Item 8.01. Other Events.

On May 19, 2014, Highwoods Realty Limited Partnership (the "Operating Partnership") and Highwoods Properties, Inc. (the "Company") entered into an underwriting agreement with Wells Fargo Securities, LLC and Jefferies LLC, as representatives of the several underwriters named therein, relating to a public offering of \$300,000,000 aggregate principal amount of the Operating Partnership's 3.20% Notes due June 15, 2021. The terms of the notes are governed by an indenture, dated as of December 1, 1996, among the Operating Partnership, the Company, and U.S. Bank National Association (as successor in interest to First Union National Bank of North Carolina), as trustee, and an officers' certificate to be dated as of May 27, 2014 establishing the terms of the notes.

The notes are being issued pursuant to the Operating Partnership's automatic shelf registration statement on Form S-3 (Registration No. 333-193864-01), as amended, including the related prospectus dated February 10, 2014, and a prospectus supplement dated May 19, 2014, as the same may be amended or supplemented.

The closing of the offering is expected to occur on May 27, 2014.
