The following constitutes Amendment No. 3 to the Schedule 13D filed by the undersigned ("Amendment No. 3"). This Amendment No. 3 amends the Schedule 13D as specifically set forth.

Item 4.

Purpose of Transaction.

Item 4 is hereby amended to add the following:

On January 15, 2008, OHC Investment, Inc. ("Purchaser"), a Delaware corporation and a wholly-owned subsidiary of Odyssey HealthCare Holding Company and the Issuer entered into an Agreement and Plan of Merger (the "Merger Agreement"). Pursuant to the terms of the Merger Agreement, Purchaser commenced a tender offer to purchase all of the outstanding Shares at a price of \$8.60 per Share net to the seller in cash (subject to applicable withholding taxes), without interest thereon, upon the terms and subject to the conditions set forth in the Offer to Purchase dated January 30, 2008 (the "Initial Offer"). The Initial Offer expired at 12:00 midnight, New York City time, on February 27, 2008. Following the Initial Offer, the Purchaser commenced a subsequent offering period to acquire all remaining Shares of the Issuer at the same \$8.60 per share cash price offered in the Initial Offer (the "Subsequent Offer"). The Reporting Persons tendered into the Subsequent Offer was successfully completed on March 5, 2008. Accordingly, the Reporting Persons no longer beneficially own any Shares of the Issuer.

Item 5.

Interest in Securities of the Issuer.

Item 5(a) is hereby amended and restated to read as follows:

As of the close of business on March 5, 2008, the Reporting Persons did not beneficially own any securities of the Issuer. All Shares previously reported as owned by the Reporting Persons were tendered into the Offer.

Item 5(c) is hereby amended to add the following:

There were no transactions in the Shares by the Reporting Persons during the past 60 days other than ALS Fund's tender of 338,141 Shares, ALS Fund II's tender of 234,661 Shares, ALS Fund II QP's tender of 279,853 Shares, ALS Fund Offshore's tender of 338,780 Shares and ALS Fund II Offshore's tender of 481,915 Shares, respectively, into the Subsequent Offer at a price of \$8.60 per Share.

Item 5(e) is hereby amended and restated to read as follows:

As of March 5, 2008, the Reporting Persons ceased to be beneficial owners of more than 5% of the Shares.
