On March 9, 2005, Inland Real Estate Corporation (the "Company") issued a press release announcing the acquisitions of Mapleview Shopping Center, a 103,714 square-foot multi-tenant retail center located in Grayslake,

Illinois, and Showplace Theatre Center, a 94,860 square-foot multi-tenant retail center located in Crystal Lake, Illinois. Inland Real Estate Corporation paid an aggregate purchase price of approximately \$40.8 million for both properties.
