The reporting person has elected, pursuant to the Company's equity compensation plans, to receive deferred shares of common stock in lieu of cash for payment of director fees.

(2) On January 18, 2011, the Company granted 3,924 restricted shares as an annual grant to non-employee directors, valued at the then current market price of \$20.39 per share. Such shares vest on January 15, 2012 unless, with certain exceptions, the reporting person ceases to be a director prior to the vesting date.
